Hey Everyone! Happy 2017!

At the conference we set a goal to establish online CEs for members of our society, and here is the update for that project. After searching on various state's affiliate websites and calling several online CE providers, we have found this to be financially unfeasible at this time. Our hope was to be able to buy a credit outright for any member to use. What we found was that very few state affiliates (only 3-4) provide an online CE section, and it was for a voucher or coupon code linking to an outside CE provider. That credit is at an additional cost to the member. We called several of the online CE providers, hoping we would be able to find a company to work with our needs, but the most we could find was a 20% discount per credit, per member. If you know of someone with knowledge or experience with providing online CEs, please contact us.

With the unfortunate outcome of not being able to support online CEs at this time, we are motivated more than ever to set up a half-day mini conference in addition to our annual conference in September. We are open to any suggestions from you as to what you would like to see with this half-day session—would you like a specific modality for this session?
