ONLINE CT REGISTRY REVIEW COURSE AVAILABLE AT LCCC

Considering taking the CT Registry? We have the course for you! LCCC is now enrolling for their CT Registry Review Course for the Fall 2016 semester and registration is open! **RDTK 2950 – Computed Tomography Registry Preparation for the Technologist** is a 3-credit hour class and will officially start on October 24, 2016. It will be offered as an eight-week online course, ending on December 16, 2016.

Other important information about this course:

1) This course meets the ARRT structured education eligibility requirements that went into effect after 1/1/16. The course is available to be taken for a grade, Pass/Fail, or Audit (NOTE: If you choose to audit the course, you must still complete at least 75% of the course with a 75% or better if you wish to use this course to meet the ARRT's structured education requirements.)

2) This course is totally online, so technologists have the flexibility to complete the coursework without interfering with their normal work hours. The course will cover every content area of the CT Registry and includes practice quizzes and tests over all content. By the end of the course, students will have completed a minimum of 5 Mock CT Registries in preparation for the ARRT certification exam.

3) If you have not been a student at LCCC or have not been enrolled in an LCCC course for a while, you may need to go through the admission process and/or be readmitted first so that you can register for the class. The admission process is free, but please allow up to 48 hours from the time you apply to the time that you may be allowed to register.

And a bonus! Because RDTK 2950 is considered a work-ready course, **ALL of the tuition for this course is eligible to be covered by an A.C.T. Now grant**—this includes both in-state, WUE, and out-of- state tuition! The only caveat for receiving these monies is if you already were awarded an A.C.T. Now grant while you were a radiography student, you cannot receive this grant for the CT course. But if you haven't, you are eligible to apply.

So if you were on the fence about registering for the CT course and the cost for the class was holding you back, please contact Jeanine Steel, the A.C.T. Now Grant Coordinator. All of her contact information is below. She can get you into their system fairly quickly and get your tuition paid before the drop for non-payment date. If you have already registered and paid your tuition, you may still contact Jeanine to see about getting these costs covered through the grant.


